# Safety Warning

These instructions are intended for use by qualified electricians.

This unit must be installed by a qualified registered electrician in accordance with the current IET Wiring regulations BS7671.

Before commencing any electrical work ensure the electrical supply is isolated and securely locked off.

This Sync Energy Consumer Unit consists of a plastic enclosure, with an integral DIN rail onto which a main switch isolator or RCD is mounted along with MCB's/RCBO's, neutral and earth terminals and all connecting cables Sync Energy Consumer units / Enclosures are tested to BS EN 61439-3 standard, this tested standard verifies the safety requirements and performance of the devices installed within the unit.

Sync Energy Circuit protection enclosures have been type-tested and approved with BG Electrical circuit protection devices. When adding or replacing devices, only BG marked devices and accessories should be installed inside this enclosure.

IMPORTANT NOTE: A DC leakage fault in the vehicle may "blind" a Type AC RCD and render it ineffective, never feed any EVSE from an upstream Type AC RCD.

1. The total load must not exceed the rating of the incoming isolator or any other limiting factor.

- 2. Ensure all connections are secure and terminal screws are tightened up to the supplied torque settings see below.
- 3. DO NOT USE POWERTOOL SCREWDRIVERS ON ELECTRICAL CONNECTIONS.

## Installation

- · Remove front cover by lifting up, quarter turn screws come in the open position. NOTE: Screws are captive and will not fall out.
- Provide cable access via either of the drill out cable entries in the sides (2 x 29mm or 2 x 38mm) bottom (3 x 29mm) or base (1 x 37mm) of the enclosure. For extra sealing protection, channels.
- around the knock-out and fixing holes are provided to accept a bead of sealant (not supplied) when fixing to mounting surface. Ensure IP rating is maintained e.g. use of glands.
- Secure to wall using the 4 fixing points, the holes are slotted to enable some rotation adjustment if required. Use appropriate wall fixings to suit the mounting surface. Fit supplied Bungs over all used fixing screw positions to seal aperture recesses.
- Fit any additional devices to the DIN rail if required, ensure cables are connected to the correct devices, neutral and earth terminals.
- Ensure all connections are secure and tightened to the correct torque setting (refer to torque table above or torque label in base of product).
- Test in accordance with the current IET wiring regulations.

   Refit front cover to base, secure using the quick fastners. Turn 150° clockwise with a suitable Pozi bladed screwdriver to tighten, from to OVER TIGHTEN.
- · Apply supplied SPD and identification labels to front cover above devices.
- Close front when not in use to maintain IP rating.
